Sheriff Greg Champagne reports that following an investigation, two adults and three juveniles were arrested for multiple counts of car burglary and a residence burglary on the east bank of St. Charles Parish.

Detectives received information that lead to the identity of the suspects. Subjects allegedly broke into ten vehicles and a residence in the New Sarpy area during the early morning hours of June 19, 2011.

Subjects were arrested and booked accordingly. Brock Beck is being held on a \$20,000.00 bond and the three juveniles are being held at a Juvenile Facility in St. James Parish. Zachary Demers was given a Misdemeanor Summons.
