### ADVERTISEMENT FOR BIDS

The St. Charles Parish Law Enforcement District, hereby advertises bids for construction of **PROVIDE NEW STANDBY GENERATOR** under Project No. **11011** as follows:

Contract Owner: **St. Charles Parish Law Enforcement District**

Contract Name: **Provide new standby generator for St. Charles Parish Sheriff's Office Headquarters.**

Principal Work Location: The Contract Work will be located generally at 260 Judge Edward Dufresne Parkway, Luling, LA 70070.

Description of Basic Work: The Contract Work comprises providing and installing a new 1250KW standby generator.

Bids: Sealed Bids must be received by the ST. CHARLES PARISH LAW ENFORCEMENT DISTRICT, Parish of St. Charles, Louisiana, 260 Judge Edward Dufresne Parkway, Law Enforcement Complex, Luling, Louisiana, 70070, either by registered or certified mail with return receipt requested, or hand delivered, **no later than 10:00 a.m. local time on December 15, 2011**. Promptly thereafter, the bids will be publicly opened and read aloud in the St. Charles Parish Law Enforcement Complex. The Owner reserves the right to reject any and all Bids, and to disregard all nonconforming, nonresponsive, unbalanced or conditional Bids.

Bidding Documents: The Bidding Documents (the Contract Documents, Specifications and Drawings) are available to Contractors who are properly licensed in Louisiana or to bona fide suppliers of materials and equipment for purchase and/or review at the office of the Engineer for the contract, Provide new standby generator for St. Charles Parish Sheriff's Office Headquarters, located at 108 Royal Crescent Dr., Belle Chasse, LA 70037.

A payment of \$60.00 in cash or check payable to the Engineer will be required for each complete set of the Bidding Documents. This payment is refundable as provided in the Louisiana Revised Statutes.

Pre-Bid Conference: A Pre-Bid Conference to discuss the scope of the project and the requirements of the Bidding and Contract Documents will be held on **December 2, 2011, at 10:00 AM.** at the St. Charles Parish Law Enforcement Complex, **260 Judge Edward Dufresne Parkway, Luling, Louisiana.** Attendance of the Pre-Bid Conference is **highly recommended.**

Each bidder must deposit with his/her bid, security in the amount equal to five percent (5%) of the total bid in the form of a certified check, cashier's check or bid bond.

The successful bidder will be required to furnish a Performance and Payment Bond written by a company licensed to do business in Louisiana, in the amount equal to one hundred percent (100%) of the contract price. Certificates of Insurance will also be required as specified.

The outside of the bid envelope must contain the submitting firm's name, your Louisiana Contractors License number, the project number, and the project title.
