## ADDITIONAL CHARGES AND INFORMATION REGARDING THE ARMED ROBBERY/PROSTITUTION INCIDENT IN AMA, LA RELEASED 12/19/2011

Sheriff Greg Champagne reports an additional charge and additional information in relation to the Armed Robbery/Prostitution Incident released to the Media yesterday involving Clinton McGraw, Robin Tice, Brandon Green, and Jeremie Weber.

McGraw was rebooked on an additional charge of principle to armed robbery. On December 16, 2011, McGraw claimed to be a victim during an Armed Robbery, which occurred in Ama, Louisiana. During the investigation of the Armed Robbery/Prostitution incident, detectives learned that McGraw and Weber were both involved in the planning and execution of the Armed Robbery. The two suspects invited a prostitute (Tice) to McGraw's residence with the intent of robbing her and her pimp (Green). McGraw was arrested and booked accordingly.
