Deputies found the above subject and Nelson in a car in front of Jackson's home with family members tending to them. Kenneth Nelson has an warrant out for his arrest. Kenneth Nelson B/M D.O.B. 1/26/92 of 640 Mockingbird Lane is still in the hospital and is currently in ICU recovering from Surgery. Jackson received a gunshot wound to his arm and was treated and released from the hospital. Jackson was arrested and booked accordingly. This investigation is ongoing and additional arrests are expected.
