### Three Arrested During St. Rose Search Warrants

Members of the Special Investigations Division along with members of the Special Response Team of the St. Charles Parish Sheriff's Office executed simultaneous Search Warrants at 253 2nd Street and 717 Mockingbird Lane in St. Rose, Louisiana, pursuant to an ongoing investigation.

During the search of 717 Mockingbird Lane Officers located:

- A locked metal safe located in the front den behind a recliner which contained the following: a clear sandwich bag which contained a white powdery substance that later field tested positive for the presence of cocaine (weighed approximately 14.85 grams).
- A clear sandwich bag which contained a green-leafy vegetable matter that later field tested positive for the presence of marijuana (weighed approximately 8.43 grams).
- Container which had a green-leafy vegetable matter that later field tested positive for the presence of marijuana (weighed approximately 0.31 grams) in a bedroom.
- Charter arms revolver located in a closet, inside a coffee maker box in the living room.
- .22 caliber rifle located in southeast bedroom.
- Also during the search of the residence officers located a brown pitbull in the rear yard which had neither food nor water. The pitbull also had a heavy chain around its neck which was embedded into the dog's neck. The dog also appeared emaciated and malnourished. Animal control arrived and took possession of the dog.

During the search of 253 2<sup>nd</sup> Street, Officers located:

- A clear plastic bag containing a white powder substance located in the top southwest kitchen cabinet / field tested and weighed by with the results of the field test inconclusive and weighing approximately 2.09grams
- Assorted U.S. Currency
