Sheriff Champagne reports that two juveniles (brothers) were walking behind the Mississippi levee in New Sarpy gathering firewood when they were approached by the above listed subject and two juveniles, ages 15, both from the New Sarpy area. All three offenders took one of the victim's Nike gym bag and struck the other victim with a large piece of driftwood possibly breaking the victims arm. While the uninjured victim then tried to help his injured brother, he was "jumped" by all three offenders as well. The unknown offender then demanded that the two victims empty their pockets at which time they complied and gave them a cell phone and knife. The offenders fled the area. During the course of the investigation, the above named subject and two juveniles were identified as suspects and were positively identified by the victims.
