Sheriff Greg Champagne reports that the above subjects were arrested following an altercation with a 33 year-old Luling Man, who is the boyfriend of Arrestee #1 (Dufrene). During the altercation between the victim and Arrestee #1, Arrestee's #2 & #3 became involved and Arrestee #2 (Drolla) stabbed the victim 7 times in his back with a sharp object. The victim was transported to Ochsner Hospital for his injuries. Arrestee #1 was released on December 28th on a \$5,000 bond. Arrestee #2's bond has been set at \$500,000 and Arrestee #3's bond has been set at \$50,000.
