**CHGS: Negligent Homicide, Reckless Operation, No Seat Belt**

Sheriff Greg Champagne reports that the above subject was arrested on a warrant that was issued on December 30, 2014 for the above charges. In November of 2014, Lymous was involved in a single vehicle crash in St. Rose where his vehicle flipped and the passenger of his vehicle was ejected and thrown from the vehicle landing inside the wood line beyond the ditch. The victim was pronounced dead at the scene. Lymous did not show any signs of impairment and voluntarily submitted to a breath and blood test which both revealed he had no drugs or alcohol in his system. Lymous allegedly admitted to driving approximately 90 MPH in a 55 MPH before losing control of the vehicle. Lymous nor the victim were wearing seatbelts at the time of the accident. Lymous was arrested and booked accordingly.
