#### **Homicide – 200 Block of Meadows Drive Destrehan, LA**

Shortly after 8:00 A.M. yesterday morning, deputies were dispatched to a shooting in the 200 block of Meadows Dr. Destrehan, La. Upon arrival, deputies discovered a 25 year old black male lying face down in a driveway. He had apparently been shot in the head and was pronounced deceased. The victim is a resident of Jefferson Parish. His name is being withheld at this time pending notifications.
