<p>Sheriff Greg Champagne reports additional charges have been filed against both Lott and Hixon following a recent arrest. The initial arrest stemmed from an incident where Hixon and Lott were both occupants of a vehicle seen driving on Highway 90 at night with no headlights on immediately after deputies were dispatched to a nearby area in relation to gunshots. After a brief pursuit that ended when the vehicle crashed near Williams Blvd and Interstate 10 in Kenner, LA, Hixon and Lott were detained. The vehicle in which they were commuting in contained approximately 50 grams of Marijuana.</p> <p>Resulting from the vehicle pursuit, the vehicle was seized and a search of the vehicle resulted in the discovery of a firearm that was located inside. Both subjects were arrested accordingly.</p> <p>Through the course of this ongoing investigation, it was learned that Hixon and Lott were allegedly involved in the shooting that deputies were initially dispatched to in the 100 block of Bocage Drive in Luling, Louisiana.</p> <p>During the shooting, no injuries were reported but two houses sustained damage.
