Sheriff Greg Champagne reports the complainant advised she saw a Facebook Group post that several vehicles were burglarized in the Lakewood area. A neighbor contacted her and advised they had a video from November 15 at approximately 3 a.m. of her vehicle being burglarized. The video showed a subject entering her vehicle and rummaging through the inside. A small hatchback style sedan was observed driving on the street with the lights off. A second subject was observed walking near the sedan. Both subjects were wearing hooded sweatshirts. It appears the complainant's vehicle was unlocked.
