Sheriff Greg Champagne reports the complainant advised he received an email that appeared legitimate for a service plan. He contacted the phone number listed in the email and a male advised he could reverse the charge but needed access to the complainant's computer. The male "credited" too much and requested the complainant to purchase gift cards and provide the numbers and pin numbers to him. This has been determined to be a scam.

Sheriff Greg Champagne reports the complainants advised in November 2022, while setting up a recently purchased laptop, a message to contact the service department was received. The complainants spoke with a female claiming to work for Microsoft and informed them their personal information was found on various websites and offered to "help" them with the issue. They were forwarded to a male claiming to be a lawyer with the Federal Trade Commission. The female called them the next day and connected them again to the male. The male claimed they were being investigated for \$1.2 million in fraud. Days later, the male claimed they needed to secure their money in an investment account. He instructed them to make withdrawals from their bank accounts and deposit into Bitcoin and send him the information. This has been determined to be a scam.
