The St. Charles Parish Sheriff's Office reports contact was made with Williams during a traffic stop for illegal tint. Upon approaching the vehicle, deputies detected the odor of marijuana. Williams informed deputies that he possessed marijuana inside of his undergarments. Williams was taken into custody and booked accordingly.
