EXECUTION OF SEARCH WARRANT LEADS TO ARRESTS AND SEIZURE OF FIREARMS AND ILLICIT NARCOTICS

During the early morning hours of November 20, 2024, members of the sheriff's office, which included the SWAT Team and Special Investigations Division, executed a search warrant at 1019 Paul Fredrick Street in Luling. As a result of this operation and a subsequent search warrant executed at the residence, the following items were recovered:

- Glock 22 Handgun with extended magazine
- Glock 23 Handgun with extended magazine
- Amount of Marijuana
- Amount of Crack Cocaine
- US Currency \$3,530 (Drug Proceeds)

The culmination of the ongoing investigation over the last few months by detectives due to potential illegal drug trafficking at the residence resulted in the following arrests during the operation:

- 2 Counts-Distribution of Marijuana (Warrant)
- Possession with Intent to Distribute a Schedule I CDS (Marijuana)
- Possession of a Firearm by a Convicted Felon
- Possession of a Firearm in the Presence of a Controlled Dangerous Substance

Chrishad Brown has a lengthy criminal record. He's been arrested relative to Illegal Possession of Stolen Things, Distribution of Marijuana, Illegal Carrying of a Weapon in the Presence of a Controlled Dangerous Substance, Illegal Possession of a Stolen Firearm, Illegal use of a Controlled Drug in the presence of a person under 17 years old, Possession or Distribution of Drug Paraphernalia, Possession with Intent to Distribute Marijuana, Possession with Intent to Distribute Tapentadol Hydrochloride, Interfering with a Law Enforcement Investigation, and Resisting an Officer. Brown recently pled guilty in relation to a previous investigation for Possession of a Stolen Firearm and Distribution of Marijuana. Brown's sentence was deferred, and he was placed on active probation.

Jai Narcisse has a lengthy criminal record. He's been arrested relative to Aggravated Assault with a Firearm, Contributing to the Delinquency of a Juvenile, Obstruction of Justice, Possession of Marijuana, Disturbing the Peace, Possession or Distribution of Drug Paraphernalia, Operating a Vehicle while Intoxicated, Battery of a School Teacher, Aggravated Battery, Theft (Shoplifting) Possession with intent to Distribute Marijuana, Battery of a Dating Partner, Distribution of Marijuana, and numerous traffic offenses. Jai Narcisse also has a pending court case for the Distribution of Marijuana.
