During the investigation, detectives seized over 230 grams of marijuana. The following day, deputies attempted to make contact with a suspect, Moore, involved in the investigation. Moore was a passenger of a vehicle operated by Coleman. Both subjects fled in the vehicle. Moore was dropped off on Airline Highway where he was apprehended by deputies. Coleman was apprehended a short distance away and placed under arrest.
