BOTH CRIME AND NOW TAXES GOING DOWN IN ST. CHARLES PARISH!

Welcome to this year's edition of the *Update*. This is our 25th annual edition of this newsletter to provide you with this past year's activities of the St. Charles Parish Sheriff's Office and our deputies.

First, I am pleased to report that crime in St. Charles Parish continues to remain at historically low levels. 2021 was a 25-year record low. In 2022, we experienced the 2nd best year with a modest 5.4% increase over 2021. Thus far in 2023 during the first 6 months, we are at about the same level as 2022. While we are not crime free, we are having great success in our efforts to keep St. Charles Parish a safe place to live, work, and raise a family.

Something else is going to be lower – your property taxes. I am happy to announce that the St. Charles Parish Sheriff's Office will reduce its millage rate by .50 mills for 2023. This will result in savings to all of our property taxpayers of OVER ONE MILLION DOLLARS! We have been advised by Assessor Tab Troxler that several previously exempt industrial properties/

projects are coming out of exemption status which will result in increased ad valorem tax revenue for all taxing bodies. In light of this, it is only fair to reduce everyone's taxes for 2023. These savings will be realized on your tax bill at the end of this year. I am also pleased that we have been able to utilize our increased tax revenue by providing our employees with approximately a 15% increase in salary over the last 2 years.

In this issue, we also highlight many programs available to the citizens and youth of St. Charles Parish, including our Citizens Academy, National Night Out, TRIAD, Cub Scout Pack 211, and Eat on the Beat.

We also offer some warnings and tips regarding popular scams targeting our residents. If it sounds too good to be true, it probably is!

As our children go back to school, remember – you can help us protect them by obeying traffic laws and driving safely.

I hope you enjoy Volume #25 of the St. Charles Parish Sheriff's Office *Update*, and that you join us for some of the community and youth opportunities mentioned.

for the increase in crime are thefts and auto thefts." Murders and rapes have decreased.



St. Charles Parish crime rate still low, but with some concerns

The Uniform Crime Reporting (U.C.R.) statistics for 2022 showed a modest increase in St. Charles Parish during the calendar year. From January through December of 2022, the total number of crimes according to U.C.R. rose from 1,213 in 2021 to 1,279 in 2022 – a 5.4% increase.

According to Sheriff Greg Champagne, "The two categories primarily responsible

Congratulations, Graduates! St. Charles Parish Sheriff's Office Regional P.O.S.T. Basic Academy – Classes 36 & 37

Sheriff Greg Champagne is proud of all of the graduates from the St. Charles Parish Sheriff's Office's Regional P.O.S.T. Basic Academy. For sixteen weeks, cadets learned the skills and techniques required of a Peace Officer in the discharge of his or her duties through Louisiana P.O.S.T. (Peace Officer Standardized Training). Training ranged from classes on Louisiana Law, First Aid, Defensive Tactics, Defensive Driving, De-Escalation Training, Crisis Intervention, Firearms Training, Scenario Training, Investigation Training, and countless other classes necessary for producing well-educated, professional law enforcement officers.

Graduation marked the day that these men and women took the next step in dedicating their lives to helping their respective communities as they changed their titles from "cadets" to P.O.S.T. certified law enforcement officers.

Academy classes were comprised of cadets from the following agencies: Harahan Police Department, Office of Juvenile Justice, St. Charles Parish Sheriff's Office, St. Helena Parish Sheriff's Office, St. John the Baptist Parish Sheriff's Office, Seventh Ward Marshals Office, Southeastern University Police, Tangipahoa Parish Sheriff's Office, Tulane University Police Department, and Xavier Campus Police Department.

Academy Class 36 graduated on November 10, 2022, with twenty-one graduates. St. Charles Parish Sheriff's Office graduates are Joseph Dube, Philip Ibbetson, Michael Kinler, Dylan Nash, and Cameron Vance.

SHERIFF SWORN IN AS PRESIDENT OF THE NATIONAL SHERIFFS' ASSOCIATION

St. Charles Parish Sheriff Greg Champagne was sworn in as President of the 3,080-member National Sheriffs' Association (N.S.A.) on January 26, 2023, to serve out the unexpired term of retiring N.S.A. President Sheriff William Bohnyak of Orange County, Vermont. The ceremony was held at the St. Charles Parish Sheriff's Office Training and Special Services Center in Luling, Louisiana.

On June 29, 2023, Sheriff Champagne was reinstalled as President of the N.S.A. at the organization's annual conference in Grand Rapids, Michigan to serve a term of one full year. He previously served as the N.S.A. President during 2016-17. Sheriff Champagne has also served as a board member of the N.S.A. for 20 years and has held virtually every leadership position of the organization, including chair of the Legal Affairs Committee. This is the first time any sheriff has been elected twice to serve as President in the organization's 82-year history.

The National Sheriffs' Association was chartered in 1940 and is a professional association dedicated to serving the Office of Sheriff and its affiliates through law enforcement education and training, and through the provision of general law enforcement informational resources. N.S.A. represents thousands of sheriffs, deputies and other law enforcement, public safety professionals, and concerned citizens nationwide. Leadership and board positions are unpaid, allowing those that hold these positions to continue serving their citizens and N.S.A. at the same time.




Sheriff Champagne Presents Distinguished Service Awards and Letters of Commendation

Sheriff Greg Champagne was honored to present Distinguished Service Awards and Letters of Commendation to several employees during a staff meeting on March 23, 2023.

On July 27, 2022, deputies were dispatched to Ash Street in Hahnville in reference to a shooting. Sergeant Steven Mahan began directing assets and responses of incoming units while prioritizing the actions of officers on the scene. Detective Isaac Genova located a gunshot victim, triaged him from head to foot, located an entry/exit wound, and properly applied a tourniquet. Deputy Timbrel Lewis located a second gunshot victim who was bleeding heavily from the leg and applied a tourniquet. The victim continued to bleed, so she applied a second tourniquet and was able to get the bleeding under control.

The St. Charles EMS Director and ER Physicians stated that Deputy Lewis and Detective Genova's proper tourniquet applications saved the lives of the two gunshot victims. ★

On September 10, 2022, deputies were dispatched to Dianne Drive in St. Rose in reference to a stabbing. Deputy Henry Sill was the first to arrive on the scene and could hear someone inside the residence calling out for help. While searching for an entry point, he discovered that all of the doors and windows of the residence were locked. Deputy Sill had to force entry into the residence, where he located the victim lying on the master bathroom floor surrounded by a large pool of blood. He then triaged the victim, applied a tourniquet to the victim's leg, and began directing incoming units.

An EMT reported that had Deputy Sill not been proactive with the application of the tourniquet, the victim would have more than likely progressed into irreversible shock. He added that Deputy Sill's quick thinking, perfect location selection, and applying adequate pressure, directly impacted the chances of a positive outcome.

Attending hospital staff reported that due to the amount of blood loss and the location of the stab wound, the victim was lucky to be alive. His quick action and immediate lifesaving efforts saved the victim's life. ★

On August 27, 2022, deputies were dispatched to Maryland Drive in Luling in reference to a medical emergency involving two possible overdosed patients. After locating an unresponsive male, Deputy Douglas Miller and Detective Paul Quick administered four (4) total doses of Narcan, which were ineffective. Deputy Miller and Detective Quick determined that CPR was necessary and they began administering lifesaving techniques until EMS arrived. EMS Personnel were able to locate a pulse and transported the patient to the hospital.

The EMS Director advised that the actions of Deputy Miller and Detective Quick, specifically CPR, resulted in maintaining the blood flow to and from the brain which helped to stabilize the patient for transport and ultimately saved his life. ★

On January 23, 2023, a van drove up to the sallyport at the Nelson Coleman Correctional Center and a female exited the vehicle stating, "We couldn't make it to the hospital! Can you

help my baby?" Deputy Philip Schaefer observed a young male subject holding what appeared to be blood-soaked towels around his right wrist. He then directed them to the visitation lobby and immediately began rendering aid. Deputy Schaefer began applying direct pressure as Deputy James White made an improvised tourniquet with his belt. When he realized that it was not working he made a second improvised tourniquet from an accompanying

family member's belt, but the wound continued to bleed profusely. Sergeant Jared Yancy arrived with his department-issued trauma kit and provided an actual tourniquet, which was applied. Deputy Chris Spencer arrived with his personal tourniquet, which was also applied. Deputy Schaefer continued to apply direct pressure to stop the bleeding. He noticed that the patient's skin was cool and clammy, indicating the beginning stages of shock, and requested blankets to keep him warm. Deputies Schaefer and White then moved the patient into the back seat of Sergeant Yancy's unit to be transported to a local hospital. Sergeant Darryl Richardson provided an

escort in his marked unit. While enroute to the hospital, Deputy Schaefer maintained direct pressure to control the bleeding.

Medical Staff advised that the quick action of the deputies applying tourniquets and direct pressure resulted in stabilizing the patient and minimizing blood loss. Without the care provided, the results may have been fatal.

It is for these reasons that Deputies Schaefer and White were presented the Distinguished Service Award. Sergeants Yancy, Richardson, and Deputy Spencer are also worthy of special recognition with a Letter of Commendation. ★

Advise them that you will call them back and then contact your financial institution directly – not the number on the caller I.D. or the number they provide. Do not purchase gift cards or transfer money into a Bitcoin account to pay debts, fines, or shipping costs.

On March 23, 2023, Sheriff Champagne promoted Lieutenant Darren Gros to the rank of Captain.

Captain Gros is a 25-year veteran of law enforcement, with 17 of those years here with the St. Charles Parish Sheriff's Office. He is currently assigned as the Director of the Training Division, which operates the Regional P.O.S.T. Academy.

Captain Gros has previously been assigned to Corrections, Patrol, Investigations, and Training. While in the Criminal Investigations Bureau, he was promoted to Detective in the Special Operations Division (SOD). During his time in SOD, he was promoted to Detective Sergeant and served in that capacity for six years. In 2014, Captain Gros was transferred to the Training Division. He was later promoted to Lieutenant / Assistant Director of Training until recently being promoted to Captain. Captain Gros has also served with the Special Response Team and is currently a member of the Honor Guard. He is on numerous committees within the department and was instrumental in previous years in securing grant funding for agency project purchases which serve the citizens of this parish at no cost to them.

Captain Gros is a graduate of Southeastern Louisiana University where he received a Bachelor of Science Degree in Criminal Justice. He then went on to receive his P.O.S.T. certification from

Officers Complete Crisis Intervention Team Training

The St. Charles Parish Sheriff's Office, along with the South Central Louisiana Human Services Authority, hosted a 40-Hour Crisis Intervention Team (CIT) training course November 14-15, 2022.

Twenty-two officers from five different agencies attended and completed the 40-hour CIT certification course held at the St. Charles Parish Sheriff's Office Training Building.

These officers received training in de-escalation techniques that deal specifically with people suffering from mental health crises. Officers received instruction in mental health law, behavioral health diagnosis, suicide prevention, dementia diagnosis, autism behaviors, opioid abuse characteristics, and active listening. They also participated in Scenario-Based Response Training.

Sheriff Champagne is proud to partner with the South Central Louisiana Human Services Authority to offer this course.

Officers attended from the St. Charles Parish Sheriff's Office, Lafourche Parish Sheriff's Office, Tulane University Police, Baton Rouge City Marshal's Office, and the US Marshals Service. ★

Patrol Officers Receive Nationally Accredited Field Training Certification

The St. Charles Parish Sheriff's Office Patrol Field Training Officer (FTO) Program is a nationally accredited training program through the Applied Police Training and Certification (APTAC), which follows the national San Jose FTO Model. The officers who were certified October 14, 2022 by the Training Division (Master FTOs) were provided 40 hours of classroom instruction and practical applications of the current methods of recruit training. These officers will now be responsible for performance evaluations of newly hired or

transferred officers to the SCSO Patrol Division. The Recruit Training Program is a four-month training process over the span of four phases of training totaling 560 hours. ★

Corrections Officers Receive Nationally Accredited Field Training Certification

On April 27, 2023, three deputies assigned to the Nelson Coleman Correctional Center completed the SCSO's nationally accredited FTO (Field Training Officer) program at the Training Building. Master FTOs assigned to the Training Division conducted the 4-day, 40-hour certification modeled after the national FTO San Jose Model, conducted through the Applied Police Training and Certification (APTAC). These deputies are now responsible for training and evaluating newly hired correctional officers and lateral transfers to determine if they are ready to serve in the correctional center capacity. ★

Captain George Breedy of the St. Charles Parish Sheriff's Office graduated from the 14th Session of the Department of Homeland Security Leadership Academy (DHLA). Ceremonies were held at the Federal Law Enforcement Training Centers located in Glynn, Georgia from September 12-22, 2022.

DHLA is a two-week immersive leadership program that brings together senior law enforcement executives and command-level staff of federal, state, local, tribal, and territorial law enforcement from across the nation. DHLA attendees learn from subject matter experts in the areas of leading through crisis, resiliency, diversity, and other contemporary law enforcement topics. Participants also work closely in groups to discuss and develop proposed solutions to common challenges facing law enforcement.

There were twenty-nine graduates of Session 14 of the DHLA from twenty states and three territories (Guam, Virgin Islands, and the Northern Mariana Islands). ★

For 32 years, the St. Charles Parish Sheriff's Office has faithfully taught children from kindergarten through 12th grade how to live productive, drug-free lives. Since 1989, uniformed

deputies have led these series at schools in a classroom setting, giving them direct access and interaction with students. During the past five years alone, over five thousand students have graduated from the D.A.R.E. program in St. Charles Parish.

D.A.R.E. students learn how to make responsible decisions by understanding the true effects and consequences of drugs. They get tools on how to resist peer pressure by saying "no" to negative influences and by becoming a positive influence to their peers. Students also learn how to deal with stress by learning tips on healthy communication, both verbal and nonverbal. Lastly, they are taught the dangers of bullying, both physical and emotional, and are encouraged to help others by being a responsible bystander by informing trusted adults of what they witness. The D.A.R.E. program continues to positively influence the next generation with a consistent message year after year, decade after decade. ★

The address or location is the most important information we need from you; this lets us know where to send help. They will also ask for the phone number you're calling from and will need a brief description of the problem to determine who to send and if they need to send you more help, such as EMS or the Fire Department. When talking to the Communications Specialist please stay calm, listen carefully, give information, and follow all instructions.

Remember – just because they are still asking questions does not mean help is delayed. ★

PROTECT YOURSELF FROM FINANCIAL INSTITUTION SCAMS



Due to recent breaches, scammers are taking advantage of shoppers by claiming to be from financial institutions. They are asking for your personal information so they can "make sure your information isn't compromised." In reality, anyone who contacts you directly asking for your information over the phone, via email, or via social media is likely not authorized to do so. Do not respond to them! Instead, reach out to your financial institution to confirm if the call or message you received was legitimate. If you are contacted by a financial institution, do not give out any information until you are confident it is legitimate. One way to do this is to end the call and contact the financial institution directly. Many times you will find there is no issue with your account at all. Do not purchase gift cards or transfer money into a Bitcoin account to pay debts, fines, shipping costs, or to protect your finances.

Detectives Use Registered Security Cameras To Enhance Public Safety

It has been proven that the proper use of security cameras in a community can reduce crime as well as assist law enforcement in investigating crimes that occur. The presence of security cameras is often enough to deter would-be burglars. Investigations can be significantly enhanced with the use of video to help identify suspects and vehicles.



The Criminal Investigations Bureau (CIB) of the St. Charles Parish Sheriff's Office maintains a confidential database of security cameras. Information about participants in the program will remain anonymous. In the event of a crime on or near your property, detectives may ask to review your surveillance video recorded during a specific timeframe to help in the evidence-gathering process. This database builds a safety net around St. Charles Parish that grows with each new registration and continues to be a powerful resource for fighting crime.

Internet purchase exchange location

It is estimated that about 80% of Americans have shopped online, with 22% of them doing so at least once per week. With consumers moving rapidly towards online shopping, there are more and more people looking to take advantage of others. As a response to this risk to our residents, the St. Charles Parish Sheriff's Office has created an Internet Purchase Exchange Location for the safe exchange of goods or payments due to internet commerce. This "safe space" is at the Special Services and Training Center, located at 220 Judge Edward Dufresne Parkway in Luling.

Located at the entrance of the Special Services and Training Center parking lot, residents can finalize the sale or purchase of online items with the comfort of a 24-hour video surveillance camera. This also helps limit the exchange of personal information and reduces the potential dangers associated with meeting a stranger in a secluded place. "With the increase in people buying and selling items online and through social media we want to offer a location where people can feel safe making the exchange," said Sheriff Champagne. ★



PACKAGE THIEVES ARE ON THE LOOKOUT!

Porch Pirates or Package Thieves are always on the lookout for opportunities, so please be prepared and take precautions!

With the popularity of online shopping and more packages arriving at your home, you can expect the Porch Pirates to make their move. We understand that most people work and unfortunately must leave packages out on their doorstep all day until they return home.

Please be vigilant in your neighborhoods. If you see vehicles following delivery trucks or those that appear to be aimlessly driving in your neighborhood, contact the St. Charles Parish Sheriff's Office.

Sheriff Champagne suggests that if you have a friend, family member, or trusted neighbor available, contact them and ask them to retrieve your delivered packages instead of leaving them on your porch. When you

order online, request shipping updates so you can receive text messages of expected delivery dates and times. If possible, have the package delivered to your work to prevent it from being left unattended outside your home. Even consider having the online order shipped to a store for store pickup instead of having it delivered to your home.

Remember, the quicker you can get your package(s) picked up and secured, the less time that these Porch Pirates have to steal them. Sheriff Champagne urges all citizens to stay alert and observant and know your neighborhoods, neighbors, and neighbors' vehicles. Level 1 Concealed Carry Classes



The Level 1 Concealed Carry Class is designed to meet the necessary requirements for a first-time concealed carry permit or renewal in the state of Louisiana. This class involves classroom instruction, as well as instruction at the shooting range where students will demonstrate proficiency with a handgun.

Topics covered include:

- Who can apply for a permit
- How to apply for a permit
- Laws pertaining to concealed carry
- Safe handling of a firearm
- Selecting the proper firearm
- How to conceal your firearm
- Fundamentals of shooting
- Additional topics



Students are not required to bring a firearm; however, they can bring one if they choose. Students are required to bring their own ammunition. The cost of this class is \$100, payable by cash or check made out to the St. Charles Parish Sheriff's Office. Classes are scheduled based on the range availability and demand for the class. HOME INSPECTION, SECURITY & SAFETY PROGRAM

The St. Charles Parish Sheriff's Office is once again partnering with local firefighters to offer free home inspections to residents who want to make their homes safer from criminals and fire hazards. The Home Inspection, Security & Safety Program exists to assist residents in identifying potential safety issues while offering advice and best practices when issues are identified.

Firefighters inspect for frayed electrical cords, trip hazards, and aging or "daisy-chained" power strips. In addition, they will check the expiration date and functionality of any fire extinguishers on site.

Personnel from the St. Charles Parish Sheriff's Office inspect for any areas of vulnerability that may make your home susceptible to burglars or other criminal activity. This includes places where burglars can easily hide outside the home, like overgrown bushes or unlit areas. They may also recommend installing a home security system with video surveillance.

If your residence is already equipped with video surveillance or a monitored alarm system, here are some additional tips for your safety:

- Get a security system with a cellular backup. Burglars will often cut phone lines to prevent traditional systems from notifying the service provider.
- Make sure the battery backup is fully charged. Most batteries will beep or send a notification when low.
