## Signs of a Battering

### Personality:

- Jealousy - Jealousy is not love, it's a sign of possessiveness and lack of trust.
- Controlling Behavior- Batterer angers when rules are broken or challenged.
- Quick Involvement - Most battered women date or know the abuser for less than six months.
- Unrealistic Expectations - Expect the partner to meet all of their needs.
- Isolation - Cuts the victim off from all resources and supports.
- Blames Others for Problems/Feelings - Is chronically unemployed, believes someone is "out to get him."
- Hypersensitivity \* Easily insulted, claiming his feelings are hurt when he is really mad.
- "Playful Use of Force In Sex - May like to throw the victim down or hold her down during sex. May demand sex.
- Cruelty to Animals and/or Children - Brutally punishes animals, is insensitive to their pain and suffering and/or may kill them.
- Verbal Abuse - Degrades or curses victim
- Ridgid Sex Rules
- Dr Jekyll and Mr Hyde - prone to sudden mood changes

## Where Do I Begin?

### **1. Reporting –**

Domestic Violence is not a "family matter." It is a criminal act and is treated as such by the St. Charles Parish Sheriff's Office. Domestic violence incidents should be reported to sheriff's deputies, who will take appropriate action.

### **2. Protection –**

You have the right to obtain a protection order, which instructs the abuser to stay away from you or your children. This protection order is filed with the Clerk of Court and must be signed by a judge. You can get a protection order by seeing a Victim's Assistance Coordinator at the St. Charles Parish District Attorney's Office. For more information, call (985) 783-6264.

### **3. Professional Assistance –**

A state-funded program called "Victims Reparations" will help reimburse certain expenses incurred as a result of a domestic violence incident. For example, the program will pay medical treatment and therapy for the victim and/or children in domestic violence cases.
